



BUREAUCRATIC CONFUSION ACT

Ratified by the Department of Financial Nonsense

PREAMBLE

Whereas confusion is the foundation of all solid bureaucracy,
Whereas \$IDK has been launched with maximum transparency and minimum logic,
And whereas we believe all regulations should be funny at first and terrifying upon rereading --

This Act establishes the official doctrine of disorder within DFN.

ARTICLE I -- PURPOSE

This Act exists to:

- Make nonsense legally binding
- Justify the use of vibes in fiscal strategy
- Empower \$IDK as the sovereign currency of uncertainty

ARTICLE II -- DEFINITIONS

- Utility:
